The funds will be used to hire a Project Coordinator whose duties and responsibilities will be to oversee policies for the Age Friendly Action Plan, reach out for input from community members and partners to refine and implement the plan, and oversee steering committees. Ms. Reilly advised that she has received letters of support for ARCAL, Ellenville Regional Hospital, Health Alliance and Live Well Kingston who have all agreed to form partneships with the project. This is a 2 year position – 70% from Grant, 30% from County. Ms. Reilly anticipates the continuation of the position beyond 2 years.

Resolution Summary: This resolution pertains to an agreement for funding to Cornell Cooperative Extension Association Of Ulster County.

Discussion:

Cornell Cooperative Extension Association Of Ulster County Executive Director Jared Buono presented. Mr. Buono thanked the Legislators for past support. Appropriations primarily support agriculture and 4-H in Ulster County as well as nutrition and environmental work in some communities. There have been many changes in agriculture recently and the funding helps keep highly educated and skilled personnel in the office to assist those industries. Mr. Buono noted that according to the Brewers' Association, the farm brewery industry alone in Ulster County is worth \$85M in economic impact. There are well-attended new farmer classes being taught; continuing to support commercial horticulture working a lot on invasive species; working on attracting more 4-H Club leaders to keep the club program growing in Ulster County. Mr. Buono advised that he is seeking additional funding this year for an environmental program. Most Coperative Extensions have an environmental program. Ulster County's environmental program is limited exclusively to the New York City Watershed. Mr. Buono envisions an environment educator to bring the same level of education and information provided through the DEP NYC Watershed to the rest of Ulster County and reported that the job posting is puble and shared it with the Legislators. Mr. Buono is working with Soil & Water to ensure there is no overlap/duplication of efforts.

There will be a meeting between legislators and the college to advance the program and possibly establishing partnerships within the County for the benefit of future employment for students.

Legislator Criswell asked if the college is affected by the coronavirus. President Roberts reported that the situation is being monitored very closely but, as of yet, it has not.
