WHEREAS, the goal of the NYSOFA Age-Friendly Planning Program is to help communities become healthier and more age friendly. This will include incorporating age-friendly and healthy community principles into all relevant policies, plan, ordinances and programs; and

WHEREAS, the term for the NYSOFA Age-Friendly Planning Program is January 1, 2020 through December 31, 2021; and

WHEREAS, if the County's application is approved, the funds will be used to reimburse the County for age-friendly planning expenditures incurred by the Ulster County Office for the Aging, including salaries and benefits; and

WHEREAS, reimbursement for County expenditures will be available after submission by the County, and approval by the NYSOFA, of an application, standard assurances, program narratives and program budget; and

WHEREAS, the Director of the Office for the Aging requests the Chair of the Ulster County Legislature be authorized to execute the NYSOFA Age-Friendly Planning Program Application, with required assurances, and any amendments thereto; now, therefore, be it
