WHEREAS, the project expenditures in the amount of \$434,730 for the Development Court Lighting Retrofit, were approved in the 2023-2028 Capital Program; and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 611 be amended to increase the funding available for construction in the amount of \$450,000.00 for a total project cost of \$505,000.00; now, therefore be it
