Legislator Ronk said the reduction of \$5,000 in Walker Valley Burn Panels would most likely be the last time we would fund the association due to the county funding a fire training facility. Legislator Bartels said she also spoke to Gary, and she believed we have full confidence they can bridge the gap for one year. She wanted to reiterate this reduction would be a onetime thing. Legislator Belfiglio, stated regarding the transfer of funds from Awareness, the committee asked the director to come answer questions for the committee. Marie Shultis gave a packet to the committee with the breakdown of communications between her and the county. Kevin Barry spoke regarding the current condition of the Awareness contract and what would be needed for it to be executed. He stated he is volunteering his time for Marie because she has helped a few of his clients. A discussion ensued on the topic of the condition of the contract.
