Chairman Gerentine noted that those tasks included design work and asked Mr. Doyle to break the environmental tasks into a separate contract so the legislature would have an opportunity to review the finding before they approve funding for design plans and suggested the committee postpone any decision on this resolution until next week's Ways and Means meeting at which time it could be amended.
