Resolution Summary: This resolution will allow the Chairman to accept a grant from the New York State Department of Environmental Conservation to be used to further Ulster County's Climate Change Adaptation Planning Project and assist other municipalities with this challenge.

Ms. Lavalle distributed an outline of the project goals that included a statement of need, anticipated timeline, budget and other information. She explained plans to help local municipalities plan mitigations and conduct a vulnerability assessment and set local goals for adaptation to deal with them. She discussed

creating a "tool kit" and the successful model of using environmental planners with Cornell Cooperative Extension to provide technical support.

The committee discussed several aspects of this two year program, the data that would be used and how this program can benefit Ulster County and the region.

Resolution No. 142 - Amending Capital Project No. 488, Installation Of Shoulders Along Route 299, Towns Of New Paltz And Gardiner – Transportation Improvement Project (TIP) Not On The State Highway System – Amending The 2018 – 2023 Capital Improvement Program And Declaration Of Intent To Serve As Lead Agency Under SEQRA Department Of Public Works (Highways And Bridges)

Resolution Summary: This resolution will amend Capital Project No. 488 to widen the shoulders along Route 299 in the towns of New Paltz and Gardiner and declares Ulster County's intent to act as Lead Agency under SEQRA.

Climate Smart Committee

Legislator Greene discussed two vacancies on the Climate Smart Committee (CSC) and several upcoming events including additional presentations by Tim Guinee "Climate Change and Hope in Ulster County".

Legislator Greene distributed an updated draft of the goals of the CSC for 2018 and the draft of Green Business Challenge. The committee discussed various ways to engage business.

Legislator Greene reported on several other events that are going on around the region. She also passed around copies of Scenic Hudson's "Clean Energy, Green Communities – A Guide to Siting Renewable Energy in the Hudson Valley" and The Nature Conservancy's report "Accelerating Large-Scale Wind and Solar Energy in New York.

Ulster County Environmental Council

Mr. Haldeman reported on the proposed Town of Ulster Power Plant. The Council drafted a letter regarding environmental concerns and offered expertise to explore those concerns.

The Town of Shawangunk is considering a proposal for a solar farm on the historic Borden Farm. Shawangunk set a limit of 20 acres for solar installations and established other protection for forest lands. The NY State Public Service Commission recently took responsibility for siting of larger solar projects and they may override local jurisdictions. The committee discussed how this may impact home rule and other concerns regarding solar installations.

The committee had a discussion about disposal of pharmaceuticals and "sharps".
