Old Business:

The committee discussed the future of the 3 housing groups, what progress they are making and how they want to proceed in the new year. Leaders and members of each group reported their plans. Chair Walter would like to see some tangible reports, recommendations and/or resolutions early in the new year.

Director Doyle gave the committee an update on the Golden Hill housing project. Legislators asked for affordability thresholds pursuant to the Penrose PILOT agreement.

Legislator Erner mentioned a letter to Westchester Medical Center he is working on.

Legislators discussed the collection of salary information through the procurement process and the salary study the county is doing for internal nonunion positions.

Legislators briefly discussed progress at 21 Elizabeth Street property.

New Business:

Legislator Erner asked if Legislators could expect any information on a mental health quality that resulted in a death in Wawarsing currently being investigated by the Attorney General. Chair Walters suggested asking general questions, not case specific, regarding where mobile mental health services are available. Legislator Nolan suggested requesting a formal debriefing of how the program worked that could preserve confidentiality. A discussion ensued.

Legislator Erner shared a list Office for the Aging provides on housing resources. He asked if the new case manager in that office might be a resource for senior housing. Chair Walter explained how this case manager would help seniors navigate several programs including enrolling individuals for food service.

Chair Walter wants this committee to focus on mental health services, the role of the new Mental Health Commissioner, and look at how this first year with this service model has progressed. She envisions sitting

down with the Commissioner to hear her vision and developing a 5-year plan. It may need to happen in a special meeting. Legislator Petit discussed recent information from the Crisis Stabilization Center reporting 3351 calls for the mental health unit. A discussion of potentially expanding these services ensued.
