Resolution No. 309: Authorizing The Chairman Of The Ulster County Legislature To Amend A Lease Agreement With Ulster Savings Bank For Public Defender Office - Department Of Public Works – Buildings And Grounds

Resolution Summary: This Resolution authorizes the Chairman to amend a lease agreement with Ulster Savings Bank for offices of the Public Defender on the second floor of 280 Wall Street, Kingston, N.Y. for a term commencing July 15, 2018 through September 30, 2020 at an annual additional cost of \$4,732.00 for an additional 338 square feet of office space.

Greetings:

There is a two-part answer to your inquiry regarding space needs.

First, beginning July 16th, our shared services agreement with Dutchess County expands from criminal defense "conflict cases" to include family court adult representation. This will further reduce assigned counsel expenses of both counties while maintaining, if not enhancing, the quality of representation. This new expansion also includes a part-time legal secretary (Legal Aide). Thus, effective July 16th, Dutchess County is providing office space and furnishings for three Ulster County employees (two full-time Assistant Public Defenders and one part-time support staff position) and Ulster County needs to similarly accommodate the Dutchess County three employees.

Ultimately, it is our plan that, upon the opening of the new Family Court on Albany Avenue (expected in January), we will relocate the Dutchess County personnel to office space adjacent to the new Family Court. The timing is perfect because new funding from the state to reduce public defense caseloads will result in new hires by the Ulster County Public Defender office. Those new hires will be able to move into the new USB space vacated by the Dutchess County personnel.

The subject space above USB at 280 Wall Street is one flight above our current space and across the hall. We currently use cubicles for several attorneys. The cubicles do not lend themselves to the needed privacy of attorney/client meetings, but we make do by utilizing our conference room when necessary. The new space in USB building will ultimately permit us to address some of these deficiencies by perhaps relocating attorneys and providing the less private cubicles to support staff.

Most importantly, the new significant state funding is permitted to be applied to office space rental expense so there should be no fiscal impact to the County in connection with this resolution.
