**Resolution No. 269:** Authorizing The Chair Of The Ulster County Legislature To Execute A Lease Agreement With Kaatskill Development Holdings, LLC, For A Substation Of The Ulster County Sheriff's Office – Public Works – Buildings And Grounds

**Resolution Summary:** This resolution authorizing the Chair of the UC Legislature to execute a 5-year lease agreement with Kaatskill Development Holdings, LLC for a sub-station located at 146-152 Mount Pleasant Rd., Mt. **Resolution No. 270**: Amending The 2022 - 2027 Capital Improvement Program -Establishing Capital Project # 634 - Ulster County Law Enforcement Center Kitchen And Laundry Equipment - Amending The 2022 Capital Fund Budget - Ulster County Sheriff's Office

Professional Care Medical Practice P.C Professional Care Dental Services P.C. for reasonably necessary medical and dental care for inmates under the care and custody of the UC Sheriff at the UC Jail facility. 100% County Amd. Term 5/1/22 - 4/30/23.

**Discussion:** Sheriff Figueroa provided an overview of the one-year extension providing 24/7 medical care at the jail, noting inmates with insurance are charged when treatment is needed. The COVID pandemic limited the insurance payment process. Warden Becker to update the Sheriff when the normal process with resume. Committee discussion ensued.

**Resolution Summary:** This resolution approves the execution of a contract amendment #10 for \$12.1K causing the aggregate contract plus amendment amount to be equal to \$50K with Visual Computer Solution Inc. for support and maintenance of the Police Officer Scheduling System and Correction Officer Scheduling System (POSS/COSS). 100% County, Amd. Term 6/1/22 - 5/31/23.

**Discussion:** Sheriff Figueroa provided an overview of the VCS payroll/overtime system. Jarrid Blades, Commander of URGENT and Chief Administrator provided an overview of scheduling and the payroll process for 285 employees, noting the program can accommodate payroll variables and only requires one payroll employee. Chair Uchitelle confirmed the \$12K fee amendment renewal will require annual approval above

\$50K. Chair Uchitelle inquired why the Sheriff's office use different software from the rest of the county departments. Sheriff Figueroa expressed his office staff requires 24/7 coverage – a multitude of shift work requiring a different software – administrative hours, overtime, 8 and 12 hours shifts for three blocks, A, B & C line, special teams, call outs, shift differentials, etc. Deputy Exec. Kelly expressed the rest of the county payroll is not as complex, noting only 911 is 24/7 and on the same schedule, and the rest of the county utilizes the vendor Time Force. Chair Uchitelle for the record wondered if IS has other recommendations and if the entire workforce should utilize the same software. Committee discussion ensued.

**Resolution Summary:** This resolution authorizes the Chair of the UC Legislature to execute an agreement with the UC Board of Cooperative Educational Services to provide a Deputy Sheriff to serve as a part-time school resource officer. \$53.2K Term 7/1/22 - 6/30/23

**Resolution No. 277**: Authorizing The Chair Of The Ulster County Legislature To Execute An Agreement With The Rondout Valley Central School District To Provide A Deputy Sheriff As School Resource Officer – Ulster County Sheriff

**Resolution Summary:** This resolution authorizes the Chair of the UC Legislature to execute an agreement with the Rondout Valley Central School District to provide a Deputy Sheriff to serve as a full-time school resource officer. \$111,054.66 Term 9/1/22 - 6/30/23

**Resolution No. 278**: Authorizing The Chair Of The Ulster County Legislature To Execute An Agreement With The Onteora Central School District To Provide A Deputy Sheriff As School Resource Officer – Ulster County Sheriff

**Resolution Summary:** This resolution authorizes the Chair of the UC Legislature to execute an agreement with the Onteora Central School District to provide a Deputy Sheriff to serve as a full-time school resource officer. \$111,054.66 Term 9/1/22 - 6/30/23

**Discussion:** Sheriff Figueroa provided an overview of the three locations request for SRO's and the need to have a resource officer professional, noting certified SRO's selected today require a different skill set and is not like the old days. The schools perform their own interviews. The Sheriff highly recommends the committee google "C-PASS" program, Committee On Policing And Safeguarding Schools. <a href="https://www.c-pass.org">https://www.c-pass.org</a>

Legislator Hansut confirmed the schools reach out to the Sheriff's office to hire an SRO. She also expressed having an SRO at the school is definitely an asset, especially after COVID. Legislator Hewitt plans to visit his district SRO on the Sheriff's recommendation. Chair Uchitelle noted the need for all officers to be equipped with the same skill set out working/interacting with the general public. The requests are not in his district, thus will move the resolution through committee but will consider his stance when the full body meets on the 17<sup>th</sup> as his constituents have expressed concern with the KPD SRO's. Committee discussion ensued.

**Resolution No. 279**: Authorizing The Chair Of The Ulster County Legislature To Execute A Contract With The New York State Division Of Criminal Justice Services - Raise The Age Program - Department Of Probation

**Resolution Summary:** This resolution authorizes the Chair of the UC Legislature to execute a contract No. C524127 and any amendments with NYS Division of Criminal Justice Services for the Raise The Age Program for the period 4/1/2021 through 3/31/22 in the amount of \$720K. This contract will pay for program staff salaries, restorative justice programming, juvenile accountability board, transportation, and portions of the debt service for the construction of the Restorative Justice Center.

**Discussion:** Deputy Executive Chris Kelly provided a detailed overview on behalf of Probation Director Nancy Schmidt, who was unable to attend the meeting. The Restorative Justice program after 2 years (due to COVID) is starting to ramp up again. State funding is for the preceding year – last year's reimbursement. The state is a year away from all Raise The Age funding. Deputy Exec. Kelly noted DCJAS has not asked for the plans as yet, however we're confident the appropriation is there. The State fiscal year calendar runs 4/1 - 3/31. See summary detail above. Committee discussion ensued.
