So, Sajaa, if you would like to weigh in on these and make any comments or thoughts about any of them feel free to do so.

## Sajaa Ahmed

Absolutely. Thank you, Legislators and Legislator Fabiano for having me. I don't usually appear before this committee. So, I just wanted to clarify all of these - kind of mouthful of resolutions. Basically, we're asking and receiving money from the state and the federal government. These are funds that are already allocated to Ulster County area transit.

## Sajaa Ahmed

But part of the process of actually receiving the funds is that it goes through the Legislature. That's what we have to submit to both the federal government, the FTA, the Federal Transit Administration, and New York State DOT.

## Sajaa Ahmed

So, the actual Capital Projects that these funds pertain to include the Electric Bus Project that's been ongoing now, since I started with the county about two years ago. And we're finally at the point that we can issue a purchase order by the end of this year if these resolutions are passed. So, that's why we have so many of them together.

## Sajaa Ahmed

I don't like to do this, where they're all you know, together. But, basically, we will be increasing our Capital Project for No. 529. That's the final resolution. And all of the grant applications are rolled up into that amendment to the Capital Project. And

there are no county dollars required for any of these projects. It's all state and federal funding.

## Sajaa Ahmed

I am hopeful, and last week, I participated in the New York Public Transit Association's Annual Conference. We're all kind of hopeful that the state will continue to be providing these capital funds that they have for the past five years that's enabled us to really modernize our fleet. But like everything, because of COVID, it's a little bit up in the air. We were lucky enough to get nearly a million dollars last month allocated to UCAT.

## Sajaa Ahmed

So, if you... with that, if there are any questions about specific resolutions, I'm happy to take them.

## Chairman Fabiano

Any of our Legislators have any questions on any of these resolutions?

#### **Nettie Tomshaw**

Manna.

## **Legislator Greene**

I just wanted to... I don't have any questions, but I thought maybe we should formally block them. Do we need to do that? So, I was going to offer a motion to block them. Block resolution number...

All opposed. Motion carried.

## **Legislator Litts**

I'll be abstaining.

## Chairman Fabiano

Legislator Litts abstains due to work issues.

## Chairman Fabiano

Resolution No. 408: Approving The Execution Of A Contract Amendment For \$219,495.00 Entered Into By The County – Greenman-Pedersen, Inc. – Department Of Public Works.

#### **Chairman Fabiano**

For rate. What's going on here?

# **Deputy Executive Rider**

This is Construction Inspection Services.

Okay for that bridge for the Malty Hallow.

# **Deputy Executive Rider**

Yep.

#### **Tom Jackson**

Yep.

#### Chairman Fabiano

Yep. I'll entertain a motion to move it.

## **Legislator Greene**

I'll move it.

#### Chairman Fabiano

A motion made by Legislator Greene to move it. Do I have a second?

## **Legislator Cahill**

I'll second it, there's only three of us.

## Chairman Fabiano

I know. Motion seconded by Legislator Cahill. All in favor?

## **Committee Members**

Aye. (3-0) Abstained Litts.

#### Chairman Fabiano

All opposed. And Legislator Litts. You have to abstain, right?

# **Legislator Litts**

Yes, I do.

## Chairman Fabiano

Alrighty. And the final Resolution No. 409: Approving The Execution Of A Contract Amendment For \$26,794.00, Causing The Aggregate Contract Plus Amendment Amount To Be In Excess Of \$50,000.00 Entered Into By The County – Tri-County Refrigeration, Inc. – Department Of Public Works

## Chairwoman Greene

Can I just ask for some background on this? I don't remember it.

# **Deputy Executive Rider**

This is our, our chiller maintenance for UCOB and UCLEC. So, this is an annual maintenance contract.

# **Legislator Greene**

Thank you.

## Chairman Fabiano

Manna Jo, did you have another question?

# **Legislator Greene**

No, I was going to move it, make a motion to approve 409.

## Chairman Fabiano

Motion made by Legislator Greene.

## **Legislator Cahill**

I'll second.

#### Chairman Fabiano

Second by Legislator Cahill or Herb can. All in favor?

#### **Committee Members**

Aye. (4-0)

## Chairman Fabiano

All opposed? Motion carries.

## Chairman Fabiano

Okay, that concludes our resolutions for tonight. Does anybody here have any new or old business that they would like to bring up?

## **Legislator Greene**

I have a quick question, if I may.

Go ahead, Legislator Greene.

## **Legislator Greene**

If I'm not mistaken in Energy and Environment, there was a PILOT for solar and that usually comes to public works, as well. I am a little confused. And I could be wrong, but I was just... I remember thinking, expecting to see it here as well. But if it doesn't come to mind, don't worry about it. If it's... if it's still confusing me. I'll reach out directly.

## **Deputy Executive Rider**

I mean, we submit these and then Vicky chooses which committees they are supposed to go to. So, I don't know whether... I don't remember whether they've come here or not. I know they've gone to Ways and Means and Environment. I don't recall whether they've come to this committee.

## **Legislator Greene**

Okay. Not an issue, but I just was expecting to see it and didn't, so, I thought I'd ask. But if I have any further questions, I'll reach out directly.

#### **Nettie Tomshaw**

I'll double check.

#### Chairman Fabiano

Does anybody have anything else? Nettie, you could check on that?

#### **Nettie Tomshaw**

No, right now, though. I don't have access to them. But do you know the resolution number, Manna?

## **Legislator Greene**

I don't. I could look it up and I probably should have. But it's not a big deal at all. I just am delighted to see that we keep getting these quote reverse PILOTS. It means that solar is being installed in the county in in fairly large quantities.

## **Legislator Greene**

I do want to just bring up something that is starting to occur because I think we'll probably see more of it in this regard. And that is we just saw a wonderful project approved in the Town of Marbletown. A large solar project on ag land that they were unable to get anyone to either farm, or, you know, use for haying or any other

purpose. And so, they were approached by a solar company and, and that has been at least approved by the Planning Board. So, we'll probably see a PILOT on that.

## **Legislator Greene**

But there's another project down the road a little further down 209 in, I don't know if it's Town of Rochester, or Wawarsing, kind of right on the border there. And there's some controversy about it, because it is prime farmland in a floodplain, etc. And I know that the Wallkill Valley Watershed Alliance is looking into it. And I think Scenic Hudson in is looking into it.

## **Legislator Greene**

And the reason I bring it up is that, um, there are state guidelines. There's been a document published that was the result of a collaborative roundtable underscoring guidance for what are good locations for large solar arrays and what are not in terms of, as much as possible, not clear cutting, preserving prime farmland, and other criteria. And favoring areas that are already built. Large, paved areas, parking lots, and also marginal land, brownfields, landfills, etc.

## **Legislator Greene**

Some of that has to do with, right now, where interconnection is. But I know the state is looking at encouraging modifying the grid to have interconnection possibilities near appropriate open space. But I do think we are going to be seeing more and more, you know, there's a fine line between a NIMBY, not in my backyard response, and a response that says this is not a good location for solar.

#### **Legislator Greene**

So, I just wanted for awareness, I just wanted to mention that because it is coming up. And people are very strong in their opinions, one way or the other, around solar and other forms of renewables. Any siting people have strong, strong feelings about.

## **Legislator Greene**

But it's just a, you know, ultimately, if we can't by guidance, and by, you know, organizations that focus on land use, like Scenic Hudson providing really good guidelines, and the state having guidelines. It may be that the county needs to develop guideline. But I'm not, personally, in a rush to do that, I think we can work it out with education.

## **Legislator Greene**

What's that? I'm sorry.

## **Legislator Greene**

Anyway, I'm just wanted to make folks aware. I think it's... as we scale-up renewables, which is starting to happen rapidly. And will continue to happen more rapidly because of Climate Leadership and Community Protection Act. We're going to see some real rapid scaling-up. And we want to be sure it's done well, because not only is agriculture important, and often a solar system can make a farm more viable. But our food security is also very important moving forward.

## **Legislator Greene**

So, thanks for bearing with me. We got through the agenda rather quickly. So, I took the liberty to share my thoughts on that. Thank you.

#### Chairman Fabiano

No problem. You're always welcome. Anybody else want to talk about anything old or new? No, Tom Jackson, you ready for the winter yet?

#### **Nettie Tomshaw**

You're muted.

## **Tom Jackson**

Yes, Yes, we are. We have the plows all hooked up and the sanders all ready and the... we're ready. I mean, we're not really ready, but we are.

#### Chairman Fabiano

I just hope we have a real mild winter. I can deal with that.

## **Don Quesnell**

I second that.

## Chairman Fabiano

If no one has anything else.

## **Legislator Litts**

Well, before you go, Dean, I just wanted to mention one thing. I'm sure Tom is probably aware. I don't know if he is or isn't, maybe he hasn't heard yet. But New York State is going to release in the Bridge New York Program. Within the next two weeks, they'll be calling and asking, or they'll put out their call for applications.

So, just so you know. And it's going to be a shortened period of time because it's late. And anyway, so, it'd be some additional funding for our county bridges.

## **Tom Jackson**

Thanks Herb I was aware, but thank you.

# **Legislator Litts**

Okay. I'll make a motion for adjournment.

## Chairman Fabiano

All right. Motion made by Legislator Litts to adjourn.

# **Legislator Cahill**

I will second.

## Chairman Fabiano

Seconded by Legislator Cahill. All in favor.

## **Committee Members**

Aye. (4-0)

## Chairman Fabiano

All opposed, Motion carried.
