Resolution Summary: This resolution authorizes the Chair to enter a 5-year lease agreement for office space to be used by the District Attorney's Office from 12/1/2022 to 11/30/2027.

Discussion: Legislator Uchitelle reported on a meeting with Office of Court Administration (OCA), District Attorney Clegg, County Executive staff, judiciary staff, UC DPW. He characterized the compromise they agree upon as one that "no one was happy with". He noted there are not a lot of options that are viable but the one they settled on would allow them to move forward with the vote on a lease agreement tonight.

District Attorney Clegg described the major disruption to his office operations and morale. He made it very clear that this move puts his staff in 3 locations and will impact how they interact with the court, the public and each other. He asked that the Legislature and Executive continue to seek a space solution that consolidates his staff into one space close to the courthouse.

Legislator discussed the District Attorney's priorities for space and discussed "walkability", the need to get 15 or more attorneys to and from the courthouse every day, parking issues, and being in one space together.

Legislator Walter was upset that the DA's space issues were not addressed sooner because the county has known for some time that OCA was taking the DA's space for incoming judges for some time. She compared it to the synergy with moving the Ulster County Board of Elections and ensuring they had a "better" space while not addressing this problem. She will not support this resolution.

Deputy Executive Kelly said this was not a situation anyone would choose. He became aware of the situation in September with OCA informed Ulster County this space was needed in anticipation of a new Supreme Court Justice being elected and requiring space in their home county. He emphasized that the OCA space needs are a mandate not an option. The County immediately engaged DHS and a realtor as part of the discussion on how to facilitate adding another chamber with very specific requirements in the existing courthouse space as well as finding a way to accommodate the DA's office. He assured the members that the DA's office space is a priority. In addition, they will be working with OCA next year to begin a master plan for the entire courthouse to accommodate the existing need and plan for the future.

A discussion ensued.
