skepticism regarding the addition of rubber on the tracks, and various safety concerns. Legislator Maloney also expressed concern regarding how the work

in lieu of payment is being handled.

Legislator Nolan stated that many of Legislator Maloney's concerns were discussed at the Public Works, Capital Projects, and Transportation Committee meeting. Legislator Nolan went on to explain that the polycarbonate wheels were put on the back of the cars, however, it was deemed unsafe on the front wheels as it caused derailment. Therefore, a sound diminishing coating on the section of track in question is a more feasible option and the company intends to test out various options during this contract extension period. Legislator Nolan also informed the committee that Rail Explorers was just named tourism business of the year for Ulster County and many of the businesses near the track like and appreciate the business as it is good for their business traffic.

Legislative Chair Bartels noted that the new amendment does include the noise study and the negative impact to the county and public as well as a quiet zone and time limits on operation. Legislative Chair Bartels also informed the committee that the sound difference of the track with the coating is significantly quieter and stressed the importance of getting the different portions of the track on the same contract cycle.

Director of Planning Doyle noted that when the Request for Proposal (RFP) is written it should include the noise level that is desired. The sound study will merely see if the current operation is meeting those expectations.

Chairman Gavaris stated that as long as the sound level is achieved it does not matter how or what mechanism is used to achieve the appropriate sound level.

Legislator Cahill noted that a lot of areas of concern have been addressed in this amendment.

Legislator Litts stated that the purpose of the noise study is to look at the existing level of sound and determine what the acceptable level is. There are decibel levels that are deemed acceptable or aggravating etc. and the acceptable level is what should be put in the RFP, not the method in which to achieve the appropriate level.

Legislator Ronk expressed his belief that the restrictions on this fund are too great to make it useful to the county and noted that there are other ways to protect the funds for future stabilization without the legal restrictions.

Legislator Cahill noted that even though taxes have decreased the last few years the budget continues to increase, and a day will come where the county is short on cash and need to utilize a tax stabilization fund to avoid a drastic tax increase to residents.

Legislator Maloney noted that this money only exists because the county received more tax than expected and it could be given back to the people for them to decide how to save for the future.

Deputy Executive Kelly explained to the committee that the events and climate that have occurred since the beginning of the covid era have made it incredibly difficult to accurately forecast sales tax, which has caused the huge excess in fund balance.

Legislative Chair Bartels also pointed out that our budget analysts have recommended the increase to the tax stabilization fund on more than one occasion.

Chair Gavaris expressed agreement in refunding the tax stabilization fund and that there will be a next 'covid' or catastrophic event where this money is needed.
