RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to approve any necessary documents to effectuate this resolution to allow Rent-A-Center to terminate its lease with the County of Ulster prior to the lease expiration date of January 31, 2005, but only on condition that Rent-A-Center shall first deposit with the County sufficient funds to cover payment of its obligation to pay real estate taxes to the expiration date of January 31, 2005 as well as all rent and other charges due and payable to the date of early termination, as on file with the Clerk of the Legislature or as modified with the approval of the County Attorney,
