Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman John Parete offer the following:

WHEREAS, this resolution is submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, pursuant to Resolution No. 135, dated April 7, 2009, the County entered into a Memorandum of Understanding (MOU) with the New York State Division of Parole (the State), whereby the State was allowed to use approximately 1850 square feet of space in the old County Jail, approximately two days per month, in exchange for a monthly payment of \$1,100; and

WHEREAS, the MOU was to commence on June 1, 2009 and end on December 31, 2010, and the purpose of the MOU was to facilitate the reporting process for parolees located in and near Ulster County; and

WHEREAS, on October 19, 2010, the County, having been advised by the State that it desired to continue the arrangement, adopted Resolution No. 253, authorizing the Chairman to renew the MOU for a two-year term commencing January 1, 2011 and ending December 31, 2013, at the same \$1,100 per month rate; and

WHEREAS, subsequent to the adoption of Resolution No. 253, the State determined that it desired a five-year revocable permit rather than a memorandum of understanding, and the State and the County agreed to continue the arrangement on a month-to-month basis while drafting and negotiations relative to such a permit were carried out; and

WHEREAS, the County and the State, through its Office of General Services, have completed the drafting and negotiations and have created a Revocable Permit for the same space at the same \$1,100 per month rate, to commence on July 1, 2012 and end on June 30, 2017 (subject to the State's options to renew and subject to the County's rights to revoke or terminate the Permit); and

WHEREAS, because of the inter-municipal nature of the agreement, the County Executive and the Commissioner of Public Works requests that the Chairman of the Ulster County Legislature be authorized to execute the Permit; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a Revocable Permit, and any amendments thereto, with the State of New York, Office of General Services, which Permit will allow the State Department of Correctional Services and Community Supervision (DOCCS) to use a portion of the former Ulster County jail for a five-year term, at a monthly rate of \$1,100, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,

and moves its adoption.
