WHEREAS, pursuant to Resolution No. 374 dated November 8, 2006, the Chairman of the Ulster County Legislature was authorized to enter into an agreement with New York State Division of Probation and Correctional Alternatives for Ulster County Alternatives to Incarceration Programs (C550600), and

WHEREAS, the Office of the State Comptroller has recommended that State agencies begin using contracts written for a five (5) year term rather than a multi-year contract which will expedite internal processing of future annual contractual amendments, and

WHEREAS, the Director of Probation has requested that the Chairman of the Ulster County Legislature be authorized to sign the 2007 amendment to contract C550600 with New York State Division of Probation and Correctional Alternatives for Ulster County's five (5) Alternatives to Incarceration Programs: Alternative Sentencing; Probation Pretrial; Community Corrections; Defender Based Advocate (Public Defender) and the Conflict Defender, and

WHEREAS, this amendment is for the contract period January 1, 2006 through December 31, 2010, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign a contract amendment agreements with New York State for Ulster County's the five (5) Alternatives to Incarceration Programs: Alternative Sentencing; Probation Pretrial; Community Corrections; Defender Based Advocate and Conflict Defender (Public Defender) for the period January 1, 2006 through December 31, 2010, with funding as presently approved for the period January 1 thru December 31, 2007, as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
