WHEREAS, this resolution has been submitted by the County Executive on behalf of the Board of Elections, and

WHEREAS, New York State is the recipient of United States Department of Health and Human Services funding for Voting Access for Individuals with Disabilities (VOTE) Grants to states (CFDA 93.617), and

WHEREAS, the New York State Board of Elections has allocated such VOTE grant funds to Ulster County, in the amount of \$7,792.00, to improve access to polling places for individuals with disabilities, and

WHEREAS, the Commissioners of the Ulster County Board of Elections have requested that the Chair of the Ulster County Legislature be authorized to execute a contract (NYS Contract No.T003307), and any amendments thereto, with the New York State Board of Elections, for the period January 1, 2012 through September 30, 2016, to receive the allocated funds of \$7,792.00 for State fiscal year 2011-2012, for the New York State Voting Access for Individuals with Disabilities – Polling Place Access Improvement grant, and

WHEREAS, the purpose of the allocated funds is to establish, expand, and improve access to polling places, and to increase participation in the election process by individuals with disabilities, and

WHEREAS, the New York State Board of Elections contract will be administered over the period beginning January 1, 2012 and ending September 30, 2016, now, therefore, be it
