FURTHER RESOLVED, that the Woodstock Guild of Craftsmen, Inc., shall render a true and accurate report of its operations for the year 2005 on or before January 15, 2006, with the Clerk of the Ulster County Legislature containing a true and accurate account of all receipts and expenditures, and

FURTHER RESOLVED, that the County Auditor and/or any and all officers of the County of Ulster, their agents and representatives, shall be allowed full access upon reasonable notice and at reasonable times to the books, papers, records and premises of the Woodstock Guild of Craftsmen, Inc., during the period that this Resolution is in effect for the purpose of ascertaining the manner in which the above sum of money is being used or applied, and

FURTHER RESOLVED, that the above organization agrees to comply with all applicable Federal, State and local regulations including, in particular, any forbidding discrimination by such organization,
