Legislator David B. Donaldson offers the following:

WHEREAS, the County of Ulster maintains a Jail Commissions Reserve Account from which appropriations may be made from time to time, as needed, to purchase commodities and equipment to be used at the County Correctional Facility, and

WHEREAS, the Ulster County Sheriff requests that \$54,400.00 be appropriated from the Jail Commissions Reserve for the purchase, installation, configuration and maintenance of the Police Officer Scheduling System and Correction Officer Scheduling System ("POSS/COSS"), and

WHEREAS, the purposes of Resolution 243 of 2011 (which were for the same purposes of this Resolution) were never effectuated and instead, \$50,000.00 of that resolution 243 of 2011 was allocated to another purpose (to settle litigation), and

WHEREAS, \$25,000.00 from Resolution 243 of 2011 remains available and the total cost of the POSS/COSS system remains \$79,400.00, and

WHEREAS, \$54,400.00 when combined with the leftover \$25,000.00, is necessary to effectuate the POSS/COSS System, and

WHEREAS, the scheduling software will automate scheduling thereby allowing Sheriff Office personnel to more efficiently utilize time, now, therefore, be it

RESOLVED, that the 2012 Ulster County Budget is hereby amended as follows:
