Legislator David B. Donaldson offers the following:

WHEREAS, there is a desire to reduce expenses for County taxpayers and one area of potential savings is utilizing shared services among municipalities, and

WHEREAS, the County has become aware that the New York State Department of State has issued a Local Government Efficiency Grant (RFA #11-LGE-09) which is designed to assist school districts, county governments, and local municipalities in identifying opportunities to reduce the cost of services by ascertaining appropriate methods of combining resources, and

WHEREAS, Ulster County BOCES, the County of Ulster and the County of Orange desire to join as co-applicants for purposes of a grant application, and

WHEREAS, the co-applicants wish to use the grant proceeds to solicit a study to evaluate the operation and delivery of technology services and to identify potential cost savings without compromising adequate service, and

WHEREAS, this grant funding is 90% State funds, and requires 10% matching County dollars, and

WHEREAS, Ulster County BOCES as the lead applicant, and Ulster County and Orange County as co-applicants, will seek a grant award of thirty thousand six hundred thirty-four dollars (\$30,634.00) and will commit to a local cost share of ten percent (10%) or three thousand sixty-three dollars (\$3,063.00), and

WHEREAS, the three co-applicants will divide the local cost share evenly between them, with Ulster County's share equaling one thousand twenty-one dollars (\$1,021.00), and

WHEREAS, the New York State Department of State requires that the lead applicant and all co-applicants, submit resolutions from their governing boards supporting the grant application by April 18, 2012, now, therefore, be it
