#### **PUBLIC COMMENT:** There were 3 public commentators:

- 1) Howard Baul Labor Relations Specialist with the UC CSEA Reviewed points of interest, one of which dealt with the proposal relative to cutting three (3) of the employees of the Comptroller's office. Another issue he found troubling was that of flow control with the RRA. Mr. Baul urged the Legislature not to support flow control. Final issue involved the Mental Health Department and the proposed cuts in that program. Mr. Baul noted that departments that provided services to public were being cut while number of people in management was increasing. Mr. Baul asked that Legislature not "rubber stamp" another Mike Hein budget.
- 2) Elliott Auerbach, Ulster County Comptroller Comptroller Auerbach distributed a Public Hearing Memorandum (on file with the Legislative Clerk) and reviewed specific points made in the Memorandum.
- 3) Dare Thompson, LWV Stated that it was importance to have checks and balances and that the Charter was created to accomplish that .Ms. Thompson also addressed concern with issue of flow control..
